**Important Message About What You Pay for Vaccines** - Our plan covers most Part D vaccines at no cost to you.

**Important Message About What You Pay for Insulin** - You won't pay more than \$35 for a one-month supply of each insulin product covered by our plan, no matter what cost-sharing tier it's on.

**Coverage Gap**

The coverage gap begins after the total yearly drug cost (including what our plan has paid and what you have paid) reaches \$5,030. After you enter the coverage gap, you pay 25% of the plan's cost for covered brand name drugs and up to 25% of the plan's cost for covered generic drugs until your costs total \$8,000, which is the end of the coverage gap.

**Our plan covers Tier 1 Preferred Generic and Tier 2 Generic in the coverage gap.**
